Instruction and Requirements

How to Apply

All applications **must** be written clearly or typed and must be accompanied by a videotape that meets the following standards. Please do not include anything except the completed application form, the videotape, and any required photos.

All applying teams agree that the following application is for the Drury Outdoors production program “**Dream Season Heroes**” only, and that the winning applicant will be required to complete all state and federal paperwork required by Drury Outdoors, and failure to do so will disqualify you from the Dream Season.

This is a team contest and both members of your team must fill out all information individually and completely. Only one tape for a two person team.

Length of Tape:

Maximum of 15 minutes. Anything over 15 minutes will not be considered. Show your team’s best hunting footage, your team giving interviews, how your team prepares to go on a hunt, and why your team deserves to be on Dream Season.

Tape Format:

Only Mini DV, DV Cam, or DVD (no VHS, VHS-C, 8mm). Please include what type of HD camera(s) your team will be filming with if chosen for “Dream Season Heroes”. HD is a requirement set forth by the Outdoor Channel so this is mandatory to have.

Copyrighted Material

Please do not include any copyrighted music or related material on your application video. Video that includes copyrighted material cannot be aired without the written consent of the rightful owner of the music.

What to say on your tape:

Show us who your team is and why you would be considered heroes in your community in addition to being the perfect participants in “Dream Season.” Show us where your team hunts, what kind of deer you have seen, and why your work merits you a position on the show. In addition to that show us what makes you a hero, whether it is a hero to your family, your community or your country (ie. school teachers, single parents, military members, volunteer workers, pastors, police officers, firefighters, etc...). You must have at least 1 kill on the video. **Do not apply if you have not successfully killed deer or big game on video in the past. This hunt must appear within your 15 minute application tape.**

Applications Rules and Requirements:

The following eligibility requirements must be met in order to proceed with the application process:

- I. Neither team member competing in Dream Season will have had a game violation in their past. Every individual team member selected will agree to have a background check for past game violations.
- II. You must be able to display proof of United States citizenship. Acceptable forms of proof include (without limitation) a valid US passport, a copy of your military ID card (front & back) or combination of valid US driver's license and valid social security card.
- III. You must be at least 21 years of age.
- IV. You must be in excellent physical and mental health.
- V. You must be willing to travel to 2 group hunts. We are looking to do an early season hunt in the Sep/Oct time frame and a late season hunt down south. We are always looking to come up with new hunts/locations so these are **subject to change**. All travel and associated expenses will be your responsibility.
- VI. You must be willing to hunt extensively during the rut at your home hunting areas. All travel and associated expenses will be your responsibility.
- VII. You must be willing to provide at no charge any and all related footage from your entire hunting season. All recorded footage and photographs will become sole property of Drury Outdoors.
- VIII. All teams will consist of two individuals and each must state their case for why they are considered a hero.
- IX. All winners must accept and be prepared to pay income tax on the value of all prizes as required by state and federal law.

Applications will only be considered if they are complete. Completed applications include the following requirements:

- A) Completed application form (including the signed name and likeness release) and an attached current resume
- B) Copy or proof of eligibility to live and work in the United States (either valid US passport, military ID card (front & back) or combination of valid US driver's license and valid social security card)
- C) A photo with your name written on back lightly in pencil
- D) 15-minute DVD submission labeled clearly with your names.
- E) Print or type clearly on the outside of the envelope.
